Beyond the Rhetoric Obstacles and Opportunities in Diversity, Equity, & Inclusion for Legal Professionals

As the legal profession learns to adjust to the post pandemic "new normal" in legal workplaces, there have been many questions about the social inclusion (SI)/ Diversity Equity and Inclusion (DEI) efforts in the profession since the 'Black Lives Matter' global movements, and locally with the escalating cases of workplace sexual harassment and sexual abuse cases in our profession known as the 'shadow pandemic.' Yet too many DEI trainings and initiatives designed to address this shadow pandemic are also designed to be unwelcome for people who haven't bought in to their premise. In this workshop, we will explore the most common assumptions embedded into today's DEI initiatives and discuss how these assumptions can unwittingly create polarization and resentment while undermining future efforts at inclusion. We will also consider alternative frameworks for DEI engagement in the legal profession and explore the ways in which we can do better at meeting people where they are and providing them with a meaningful place in the DEI movement.



NORTHERN COLORADO STAFF ATTORNEY – HOUSING AND EVICTION

The Colorado Poverty Law Project (CPLP) is a 501(c)(3) non-profit organization. CPLP's mission is to improve access to legal services for low-income Coloradans by: (1) providing legal advice and representation to low-income individuals through a combination of our staff attorneys and our substantial volunteer attorney network; (2) educating and counseling individuals and their support organizations on legal issues common to low-income Coloradans; and (3) supporting groups advocating for new protective laws and procedures.

CPLP is seeking to hire a staff attorney either located in the Fort Collins area, or willing to travel occasionally to the Fort Collins area, to support existing CPLP staff and CPLP volunteer attorneys in providing legal assistance to low-income Coloradans in the area of eviction and housing law. CPLP is looking for a motivated and personable attorney to:

- 1) perform intake services for individuals seeking advice or representation on eviction or housing issues, including conducting client interviews and assembling documentation;
- 2) provide technical assistance to assist clients in obtaining rental assistance or securing other resources where appropriate;
- 3) coordinate referrals of appropriate clients to CPLP volunteer attorneys;
- 4) support and guide CPLP volunteers through their representation;
- 5) perform tracking of cases for reporting purposes;
- 6)-represent clients as a lawyer for CPLP;
- 7) prepare training materials for volunteers, conduct training sessions for volunteers, and recruit volunteer attorneys;
- 8) work with CPLP staff on crafting policy and identifying opportunities for impact litigation; and
- 9) perform other duties as assigned.

Applicants must have graduated from an accredited law school and have demonstrated a commitment to public interest law. All candidates must be licensed to practice law in Colorado. The ideal candidate will also have the following qualifications:

- Bilingual in Spanish and English
- Experience conducting legal intakes for potential clients
- Ability to coordinate with CPLP staff and volunteer attorneys to ensure cases are being
 outsourced to appropriate counsel in a timely manner and cases are properly transitioned.
- Ability to ensure data collection related to pro bono cases taken by volunteer attorneys as necessary to track achievement goals for grant reporting purposes.
- A demonstrated ability to analyze and understand current state, federal, and local legislation and orders affecting the rights of tenants, landlords, mortgagors, and mortgagees, including

Colorado's F.E.D. statutes, Mobile Home Park Act, and the Coronavirus Aid, Relief, and Economic Security (CARES) Act, among others.

- A familiarity with Colorado eviction processes.
- Ability to work independently and desire to provide representation to indigent tenants needing legal assistance with housing issues.

This is a hybrid locational position, with the expectation that job functions will be performed partially at home (or alternate agreed location) and in Northern Colorado including Larimer, Fort Collins, and Adams Counties as needed and required by grant funding. Candidates must be willing to engage in community outreach using all appropriate remote or in-person (COVID permitting) options, including phone and online video conferences.

CPLP is an equal opportunity employer. Salary will be commensurate with experience within a range of \$70,000 to \$85,000 annually depending on experience. Competitive health benefits and vacation will be provided.

FULL-TIME COMMUNITY NAVIGATOR POSITION

The Colorado Poverty Law Project (CPLP) is a 501(c)(3) non-profit organization. CPLP's mission is to improve access to housing legal services for low-income Coloradans by: 1) providing legal advice and representation to low-income individuals through a combination of our staff attorneys and our substantial volunteer attorney network; 2) educating and counseling individuals and their support organizations on housing legal issues common to low-income Coloradans; and 3) supporting groups advocating for new protective laws and procedures.

CPLP is seeking to hire a full-time community navigator to support CPLP staff and CPLP volunteer attorneys in community outreach in low-income communities that are in most need of our housing legal advice and services. With the increase in residential evictions, CPLP is looking for a motivated and personable advocate to:

- engage with low-income communities, such as mobile home communities and apartment complexes, to inform residents of CPLP's services, including know-your-rights programing;
- 2. Assist the CPLP team on intake, including interviewing potential clients, collecting demographic information and documents, data storage, providing technical assistance, and interfacing with CPLP attorneys on legal issues
- 3. Develop educational materials that can be used in these resident interactions and can be posted in communities and on CPLP websites, with links to housing resources;
- 4. Assist in tenant organizing; and
- Support CPLP staff and volunteer attorneys on discrete legal issues the community
 navigator encounters, including identifying affected community members, facilitating
 communications with attorneys, and helping to gather pertinent information and
 documents.

The ideal applicant would have the following qualifications:

- Interest in low-income housing issues
- Bilingual in Spanish and English (although written translation can be provided)
- Experience in community navigation and outreach in Colorado
- Knowledge of the Colorado support services environment;
- Willingness to sponsor and participate in community organization meetings and initiatives
- Willingness to commute to Denver, Adams, and Larimer Counties. CPLP will reimburse travel expenses.

This position is being funded by year-long grants from Adams County and Larimer County. Employment beyond March 1, 2023 would be dependent on renewed funding of which we are optimistic. This is a remote position but with frequent in-person travel within Adams and Larimer counties as needed to engage with community members and facilitate outreach (subject to Covid-19 protocols) and attend periodic meetings at CPLP's facility, which is part of a co-working facility located at Alchemy Creative Workspace, 66 S Logan St, Denver, CO 80209.

Annual salary would be between \$50,000 and \$65,000 depending on experience. Travel expenses would be reimbursed. CPLP also offers a generous benefits package including health, vision, and dental insurance.
