



Larimer County Pro Bono Program

COLTAF Report - June 1, 2004

Goals & Objectives for Purpose of the Grant:

The Larimer County Bar Association ("LCBA") Pro Bono Program has adopted the priority statement of the Larimer County Colorado Legal Services ("CLS") office with which we cooperate to serve indigent legal clients in our county. In practice, most cases involving CLS's top priority areas (public benefits/health and housing) are serviced by CLS unless a conflict of interest occurs in its office. LCBA's highest volume priority area is domestic relations cases. We do not handle bankruptcy, criminal, traffic, social security, or fee-generating cases (i.e. workers compensation). The program objective is to provide legal assistance or representation to all eligible applicants in dire need. The grant's purposes are:

- A) To serve all Larimer County residents who need legal assistance, especially those who are indigent. Clients benefit from personal, one-on-one contact with our legal aid paralegal, intake attorney, and assigned attorney if needed. Clinics are offered to assist residents with dissolution of marriage, child support, and custody issues.
- B) The grant covers the costs of dues, malpractice insurance, office staff of one paralegal for part time (20 hours per week) (all other participants are volunteer attorneys), payroll and other expenses. This is an ongoing activity COLTAF has supported. (The only other long-term source for funding is Larimer County Bar Association and the minor fee charged at Pro Se Clinics.)

Achievements of Project:

The Pro Bono program of the Larimer County Bar Association has provided a system to insure that individuals who need legal representation but cannot afford it will receive assistance as long they contact our program in a reasonably timely manner. Those who are indigent, disabled, or unsafe are our highest priority. We are working to expand our services to immigrants, aliens and refugees and other individuals for whom language and cultural barriers

create barriers to needed legal services. We have recently translated our initial client letter into Spanish with the assistance of a Court translator.

Our intake system operates on a weekly basis. On Wednesdays in Fort Collins and Thursdays in Loveland, clients come in person to the intake session. They complete an application form and provide financial data to our paralegal, Ellen Holmes, who screens them for financial, geographic and topical eligibility. Eligible clients (and some ineligible ones, for the purpose of receiving a referral or brief advice only) meet one-on-one with the intake attorney and Ms. Holmes to discuss their cases and ask questions. In-person intake provides the highest quality of information and exchange between the attorney and the client at the first meeting. Some individuals presenting at intake do not qualify to receive services through the use of a volunteer attorney, but may direct them to governmental services as appropriate.

The Bar Association has a dedicated phone with voice mail so that clients may follow up with procedural questions or receive information about pro se clinics. We are especially pleased that our intake systems are reliable, predictable and efficient. We are working to improve the timely placement of eligible clients with volunteer attorneys.

Many clients are assisted by direct advice at the intake session, enrollment in a pro se class, provision of limited unbundled legal services (such as drafting a letter or assistance in completing a form) or referral to mediation. Other cases are assigned to volunteer attorneys in domestic or non-domestic law matters.

In the past years we have offered various clinics for clients including pro se divorce clinics. These clinics were operated in conjunction with CLS. Due to funding restraints on CLS, we had to temporarily stop offering these clinics. We now offer twice monthly pro se divorce clinics run by a volunteer attorney and Ms. Holmes. This revised clinic schedule began in July of 2003. In addition, the Family Court Facilitator offers twice monthly classes on Court procedures in divorce cases and we routinely refer clients to this class.

We have also prepared information and brochures to be distributed to the Court, Court staff, local attorneys, and agencies in Larimer County giving information about the pro se classes and legal resources available in Larimer County.

Impact on Underlying Need or Problem:

The program has been exceptionally successful. All eligible applicants receive services in Larimer County. We currently have applicants waiting for assignment to a private attorney. Depending on the time of the application and the nature of the matter, a client will wait between one and three weeks to have an attorney appointed. The program runs smoothly under the direction of Ms. Holmes, and coordinating attorneys in both Loveland and Fort Collins.

The statistics reported in this paragraph include Fort Collins and Loveland through May 19, 2004. The final week of May is omitted so that this report can be filed timely. We will supplement these figures if requested. In Fort Collins June 2003 through May 21, 2004. We had 48 attorney referrals. 74 clients were referred to clinics/classes. Approximately 175 people were given the advice they needed at the intake sessions, which included in some instances referring them to the correct agency for assistance or providing "unbundled" legal services, such as drafting a letter or completing a legal form. No cases were reported as referred to mediation. Of the cases referred to attorneys, the statistics are as follows:

In Loveland, 199 individuals were seen at intake from June 2003 through May 20, 2004. Of these, 14 were assigned to attorneys for assistance. The remaining individuals were given the advice they needed at the session, including referrals to the correct agencies, or to pro-se classes. Of the cases referred, the statistics were as follows:

Problems Encountered:

We have many clients who need assistance in areas our program does not cover. For example, we have a very narrow pool of attorneys who speak Spanish or have Spanish-speaking staff, and our community has numerous clients who need these services. We do have clients come in to intake on the day before their custody hearing, which has been set for months, and while we are unable to provide them representation, we can provide them advice and procedural assistance. The majority of our attorney referrals are for domestic issues, which often are emotionally charged issues. Because not all of our volunteer attorneys practice domestic law, we try to insure that those attorneys who have volunteered to handle domestic cases are assigned only domestic cases and that other civil matters are assigned elsewhere.

What We Would Do Differently:

Since the beginning of 2000, we have increased the emphasis on encouraging mediation of disputes and on providing "unbundled" legal services through the program, to assist clients with appropriate cases. We anticipate that this will continue to be a positive enhancement of our program. We also are consistently seeking the addition of bilingual attorneys for intake and assignment purposes and we hope that as our community grows, these professionals will be added to our program.

Judicial News and Updates

Scanned Document Size for E-Filing June 22, 2004

To facilitate the efficient processing of electronically filed documents within the courts, the IIS standing committee has adopted the following size limits for e-filed documents submitted by attorneys:

- 1MB per pleading
- .5MBs for exhibit increments, in 25 page increments.

It is too difficult for courts to continue opening and efficiently processing documents that exceed 1MB in size. As such, documents that exceed these limits *may be* rejected by the courts. The committee is trying to encourage law firms to use the recommended scanner settings. We are trying to reject a 1MB 1 page document, but accept a 40 page document that may marginally exceed 1MB. Court staff will need to exercise good judgment in enforcing this effort Attorneys who file documents at the recommended scanner settings should not have a problem staying within limits.

The recommended scanner settings are:

Resolution: 200dpi-300dpi Color Scale: Black and White

Document File Type: Group 4 Multipage TIFF

Scanner settings that are **not recommended** include:

Resolution: higher than 300dpi Color Scale: Greyscale or Color

Lawyers were told that Entries concerning 8:30 a.m. and 10:00 a.m. arraignment in 1A must be filed in the main office and if they file an entry two business days before the return in 1A, your office will act on the entry, pull the case from the 1A docket and send the files to the proper divisions where the clerks will contact the lawyer's office and set the pretrial. Bond will likewise be continued to the pretrial date eliminating the necessity of an appearance in 1A. If the lawyer does not file the entry two business days before, they must appear with their clients on the bond on the arraignment date in 1a, file the entry or have the 1A clerks act on the entry in 1A if filed late where they will be given a pretrial date off the sheets provided by the divisions. It will be their obligation to get it changed in the division if the date 1A gives them is not good for them.
- 2. How 1A handles bonds on revocations or other cases remaining in 1A can be set to best move that docket.
- 3. Lawyers are being told they cannot file entries in the divisions unless their client has already appeared *pro se* and moved the case to a division. However, they are encouraged to file in the main office to follow normal procedures.
- 4. Lawyers are being told they cannot put the files on the clerk's desk and leave a division on a pretrial date until they personally talk to a Division Clerk and get the new date for trial or disposition.
- 5. Lawyers are being told they need to carry their setting books or have a cell phone to call their secretary and clear dates with the Division Clerk while in the presence of the clerk on pretrial dates.
- 6. At present, Defendants arrested, bonded and returnable on the 1:30 p.m. docket in the division handling the 1:30's must appear in the 1:30 court.
