# LARIMER COUNTY BAR ASSOCIATION EXECUTIVE COMMITTEE MINUTES FROM OCTOBER 11, 2022, MEETING

## Call to Order:

President Rebekah Berry-Chaney called the meeting to order at 7:08 a.m.
Minutes: Heidi Whitaker moves to approve August 9, 2022 minutes, Andrew Priebe seconds; August 9, 2022 minutes approved (Claire Havelda and Kara Clark abstain because they did not attend the meeting). Executive Board discusses gaps in information for September 9, 2022 Fall Term Day minutes, which discussion will continue outside of the meeting with hopes of approving the September 9, 2022 Fall Term Day minutes at the November meeting.

Treasurer's Report: Dan St. John reported.

- Term Day Expense Report
o Came in under budget but over income (about \$4,600 deficit)
- Member dues update
o So far have collected about $\$ 36,000$ (typically about $\$ 40,000$ ), but Dan St. John continues to receive funds, so he is optimistic regarding dues.
- Veterans Assistance Clinic Reimbursement Request
o Beyers Law has made this request for approximately $\$ 340$ for food, but the LCBA budgeted $\$ 200$ total ( $\$ 100$ for advertising and $\$ 100$ for food). Rebekah Berry-Chaney proposes that we provide the $\$ 200$ total to Beyers Law, since the firm likely benefited from the excess food. Heidi Whitaker would like to know whether the excess food was donated to a public service organization. Next year LCBA will alert Beyers Law in advance of the event of the budgeted amount, so that they can plan better. Also, LCBA will advise Beyers Law to donate excess food to public service organization. Rebekah Berry Chaney.


## Fall Term Day Report/Feedback:

- Golf Tournament: Andrew Priebe reports
o Overall very good attendance
o One issue with scoring
o Andrew Priebe will look into a shotgun start for future years
- Dinner: Rachel Michael reports
o Overall very good feedback on quality of food.
o Lincoln Center was very good to work with.
o Since the event needed to move inside, the band was too loud, but the band was very good.
o Issue with drink tickets. Some people struggled to get their drink tickets and ended up paying for drinks.
o Biggest feedback was that the event was too formal. In the future make the event less formal.
o Center pieces made by Rachel Michael looked amazing.
o Perhaps look into Ptarmigan Country Club in the future so that golf can take place in advance, and the dinner can take place directly after, in a less formal manner. Rachel believes that we need to modify Fall Term Day to encourage more involvement.
o Claire Havelda suggests finding a middle ground, by perhaps doing dinner at a brewery.

October Professionalism Month Events (Jennifer Rice and Courtenay Patterson report):

- Professionalism Seminar/Spooky Stories from the Bench
o Was planned for October 11, 2022, but has since been canceled. Event was not advertised sufficiently, and as it came down to the wire it became clear that the event could not go forward. Professionalism Committee partners with YLD for this event. Miscommunication between YLD and Professionalism Committee led to cancellation because of lack of anticipated attendance. In the future, LCBA needs to be clearer regarding expectations of each co-sponsor. CLE Committee secured CLE accreditation, but was not involved further. In the future CLE Committee would like to spearhead these events in the future since cancellation of this Professionalism event was a very bad look. Courtenay Patterson is going to meet with the CLE Committee to create a list of action items for future events so that there is predictability with allocation of duties. Executive Committee will debrief with YLD (Fred Long) to troubleshoot this event and see where the issues were and how we can improve.

## CLE Committee (Courtenay Patterson and Rachel Michael report):

- Courtenay Patterson is going to meet with the CLE Committee to create a list of action items for future events so that there is predictability with allocation of duties. Rachel Michael is going to prepare a master form that folks can fill out for their events which will streamline advertising. Magistrate Majoros suggests that there be better communication with speakers.
- Rachel would like a master calendar for events because it is becoming difficult to schedule events. Dan St. John suggests that the events page on the LCBA website be used for this master calendar.
- CLE Committee plans to get CLE accreditation for all future events.
- CLE Committee should have autonomy and should be involved in all future LBCA CLEs.
- Anticipation is that Gayle Kish will be more involved in the future with CLEs, so Rachel and Dan St. John will work together to make sure that Gayle is not over extended.
Access to Justice/Pro Bono Program (Magistrate Majoros and Cody Knebel report):
- Ask a Lawyer Day is October 28, 2022
o Still in need of lawyers for this event (DR attorneys). Contact Ian Bonner for volunteer opportunities. If lawyers are needed, Magistrate Majoros will send an email blast asking for volunteers.
- Pro Bono Program
o Cody brings up the issue of Cindi Hendrix's raise. Cody would like to discuss performance review off line (Rebekah Berry-Chaney, Magistrate Majoros, Cody Knebel, and Kara Clark will work on this performance review), with the goal of making Cindi's job more formal and structured regarding review and expectations because she is an LCBA employee. Cody motions that the Executive Committee approve Cindi's $\$ 1$ hour raise, Dan St. John seconds; all vote in favor, so motion passes. Cody will inform Gayle Kish of raise so she can take care of the raise administratively.


## Website Updates (Rebekah Berry-Chaney reports):

- Partnership with Evan Senie, who does copy work for websites. Evan would like to advertise on our website, in exchange for Evan doing spotlights on local attorneys, which could create some good content.
- Rebekah Berry-Chaney will invite Evan to November meeting so he can describe his work and we can discuss a partnership.

Kathryn's theme for this year is "You Uniquely Belong" and she will talk about what that means to her and what that means in the context of the CWBA and will hopefully inspire those in attendance to become involved and determine how each of you uniquely belong as part of the CWBA, the Larimer Chapter of the CWBA, and to the practice of law. This event is free and registration can be completed on the LCBA website.
