LARIMER COUNTY BAR ASSOCIATION EXECUTIVE COMMITTEE MINUTES FROM MAY 9, 2023 MEETING (Held via GOOGLE MEET)

Present: Heidi Whitaker, Andrew Priebe, Dan. St. John, Rebekah Berry-Chaney, Hon. Kandace Majoros, Russell Connelly, Samantha Walsh, Tomi Hanson, Kara Clark, Jennifer Rice, Courtenay Patterson.

Call to Order: President Heidi Whitaker called the meeting to order at 7:03 a.m.

Brief introductions: President Heidi Whitaker reports. The next LCBA Messenger will be published on June 1, 2023, submissions will be due by May 23, 2023. LCBA budget meeting will be held on June 22, 2023 at 2pm (Location TBD, but we will try to allow people to attend virtually). Heidi Whitaker discusses Presidential appointees for the Executive Committee, and requests feedback from the committee. Heidi requests that Pro-Bono/ATJ, Women's Bar, and YLD each will be members of the Executive Committee with a vote. All present approve this proposal. The other appointees then are usually filled out from among CLE committee, Trusts & Estates, CBA liaison, and Family Law. Heidi proposes that among the appointees we include Family Law and CLE Committee. All present approve this proposal.

Approval of Minutes: April 11, 2023 meeting minutes were shared on a consent agenda prior to this meeting. Heidi Whitaker moves to approve the executive committee minutes for the April 11, 2023 meeting, all approve, April 11, 2023 meeting minutes are approved.

Treasurer's Report: Andrew Priebe presented the treasurer's report. There is approximately \$94,000 in the LCBA operating account along with an additional \$31,000 in the LCBA premium investment account. The Pro Bono account has approximately \$8,500. The GCLSE Program account shows a balance of \$4,000, but an additional \$3,000 was deposited in April from the Weld County Bar Association's contribution (Andrew suspects this is due to the current statement being from before that deposit was made). LCBA moved \$100,000 into a 6 month CD to take advantage of high interest rates. Overall, LCBA is still under budget with expenses for the year. The Annual Ethics Seminar raised approximately \$4,789, which, after payment of all outstanding expenses, will be contributed to the Steven J. Roy Scholarship fund. The YLD Law Day event last week raised approximately \$671, which will be retained by the YLD to pay for expenses. Andrew proposes that we increase the LCBA's website blast capacity from 5/month to 20/month, at an increased cost of \$5/month (no discussion, vote passes

unanimously). Andrew reports that the 2023 Mock Trial Competition was over budget by approximately \$82. Andrew proposes that the LCBA cover this excess expense instead of asking the WCBA for additional funds. Vote passes unanimously. (Note: After the vote, Weld County paid half of the overage before a request was made or lack of request communicated.)

Young Lawyers: Russell Connelly appeared on behalf of the Young Lawyers. Law Day was held on May 5, 2023, over lunch. Attendance was good and YLD made enough money to pay for the expenses. Next Happy Hour is May 25, 2023 at Torchy's Tacos. YLD will be discussing Summer Social at that time.

Access to Justice: Magistrate Majoros stated that Family Law Day was held on April 28, 2023, and about 100 people attended. Law Day for Older Adults will be held on August 23, 2023 at the Senior Center, and there will be many speakers. Magistrate Majoros thanks Jennifer Rice for her efforts on the annual Ethics Seminar. For Fall Term Day Justice Hart will be speaking.

Greater Colorado Law Student Internship Program: Dan St. John states that he was contacted by Sumi Lee with a request to make payments for the program. Dan states that the 13th Judicial District was supposed to contribute funds, so Dan will follow up and try to collect. Dan will work with Treasurer Andrew Priebe to make the payments requested by Sumi Lee.

Professionalism Committee: Jennifer Rice reported that the Ethics Seminar was held on April 19, 2023 (103 people attended in person or virtually). Some expenses increased (such as increased Lincoln Center cost and video editing for home study credit), and therefore the income reported by the Treasurer will be lower because there are ongoing expenses.

Board of Governors Report: Jennifer Rice stated that the next meeting is June 23, 2023 from 9-11, in-person only in Breckinridge. Jennifer is investigating who will be attending from the LCBA. Typically the past LCBA president was appointed to the Board of Governors.

CLE Committee: Courtenay Patterson reports. CLE Committee has recently put on 2 CLEs from local practitioners, which went well. CLE Committee is working with another organization (Engineering Systems, Inc. "ESI") to put on two other CLEs in August/September and November, which CLEs may be focused on accident reconstruction and science based personal injury issues. Jennifer Rice is concerned about using EDI due to sharing our membership list, etc. Courtenay doesn't believe this is an issue because CLE Committee is mainly helping to secure a space and trying to assist with LCBA member attendance, while EDI is really just presenting to whomever attends (CLE Committee will not be sharing the LCBA membership list with EDI). Additionally, EDI funds their own events. Evidentiary CLE, which was rescheduled due to weather, is now scheduled for August 29, 2023.

National Adoption Day: Heidi Whitaker would like to have a meeting in July to build decorations which can be used each year. She would like volunteers.

Fall Term Day: Heidi Whitaker reported. Fall Term Day will be held on September 8, 2023. Justice Hart will be attending and speaking. Typically the two main activities are a bike ride and the golf tournament. Heidi leads a discussion regarding location for the dinner and who to use as a caterer. Executive Committee agrees that holding the dinner at the Discovery Museum would be preferred. Caterer Food for Thought was used in the past, but Rebekah Berry-Chaney does not think they did a good job for the dinner last year (burned food, bad attitude, etc.). Dan St. John agrees to look into the Discovery Museum and will ask for a list of preferred vendors so we can discuss caterers at the next meeting. We will want to book a band again, and Rebekah Berry-Chaney has a list of possible bands. Andrew Priebe will begin organizing the Golf Tournament, which he anticipates will be held at Southridge Golf Course. Andrew believes it may be good to rotate between a few courses each year.

Women's Bar: Tomi Hanson reports that the Women's Bar had a meeting at Tap and Handle on April 20, 2023. Next meeting is May 10, 2023, at which the Women's Bar will be voting on the Women's Bar Board.

Adjournment: Heidi Whitaker adjourns meeting at 7:43am.

Next meeting will be at 2p.m. on Thursday, June 22, 2023 (the annual budget meeting).
