- <u>1.</u> <u>Call to Order and Introduction</u>: Bar President Rebekah Berry-Chaney called the meeting to order at 9:03a.m., and introduced the Executive Committee and Judges/Magistrates present.
- <u>2. State of the Judiciary</u> Chief Judge Susan Blanco reports.
 - a. Judge Blanco welcomes Judge Zehe and Magistrate Schwartz.
 - b. Courtroom Assignments:
 - i. Judge Lammons has moved to a criminal docket and Judge Dean has moved to a civil docket, including domestic relations and dependency and neglect.
 - ii. Magistrate Schwartz will be in Courtroom 1A
 - iii. Magistrate Boxberger will be in courtroom 2A
 - iv. Magistrate Christiansen will be in courtroom 2B
 - v. Magistrate Esser and Magistrate Majoros will be splitting the dockets in courtrooms 1B and 1C
 - c. Lawyers teaching for change program is up and running (Women's Bar).
 - i. 3 hour volunteer commitment
 - ii. Volunteers will teach a class for 3rd, 4th and 5th graders about the legal field.
 - iii. Then students have a jury trial based on Sponge Bob
 - iv. There are already about 50 volunteers.
 - v. Judge Blanco requests additional volunteers
 - d. Warrant Clearance Event
 - i. First version was last fall at the public library.
 - ii. 75 people cleared over 100 warrants.

- iii. COVID vaccines and driver's licenses were provided.
- e. Opportunities:
 - i. Supreme Court Justice Hart will be joining us for Fall Term Day. At this event volunteers who meet certain requirements will be honored.
 - ii. Currently posting a position for court executive.
 - iii. Weekend bond hearings will be set in the 13th Jurisdiction. Funding has been provided and it is likely that 8th Judicial will be hosting these bond hearings in the future.
 - iv. Human Relations Award. Judiciary is helping to set this up all over the state, and the City of Fort Collins honored the judiciary with this award.
 - v. Judiciary will be hosting an event for past jurors in May.

f. Numbers:

- i. Numbers are lower than normal.
- ii. Cases that are coming in are more complicated.
- iii. Judge Blanco will provide numbers if requested.
- iv. County Court and District Court are tied for the number of jury trials.
- 3. Introduction and Acknowledgement of Volunteers & Staff Rebekah Berry-Chaney acknowledges and introduces specific volunteers and staff, including Cathy Vlasak (unpaid) and Gayle Kish (paid). Rebekah shows the members the new website that Gayle Kish has been working hard on. Please email info@larimerbar.org if Members want to post anything on the website (events, changes in firm, announcements, etc.), but there is a fee.

4. Update from the Bar:

- a. President Rebekah Berry-Chaney reported
 - i. LCBA has 557 members right now, which is good.
 - **ii.** In person events have been poorly attended, likely a remnant of the COVID pandemic. LCBA continues to find ways to encourage increases in in-person attendance.
- **b.** Treasurer's Report Secretary Andrew Priebe reports for Treasurer Dan St. John
 - i. LCBA has substantial reserves. Currently the LCBA has just over \$245,000 in various accounts.
 - **ii.** Some CDs have expired or have too low of an interest rate. So, the LCBA will be reinvesting savings into staggered CDs to take advantage of higher interest rates and to allow for more flexibility with liquidity.
 - **iii.** Membership dues have been consistent with prior years. Some folks have taken advantage of our new LCBA only membership which was added in the recent revisions to the Bylaws.
 - iv. LCBA is currently on budget. As we close out the fiscal year there may be some line items that are under budget, and a few, mainly payroll related, may be over budget. Executive Committee will review this in June at the annual budget meeting and try to balance the budget.
- **<u>5.</u>** Court Resource Center Ian Bonner reported about the activities of the Court Resource Center.
 - **a.** Court Resource Center helps pro se litigants with procedural based questions, not legal advice. Help people file out forms and understand court process. Goal is to make Courthouse less intimidating.
 - **b.** Ian Bonner introduces Bailey, who is working part time for the Court Resource Center.
 - **c.** Stats: Ian reported specific statistics of the people that were assisted both in person and remotely. Numbers are very good.
 - **d.** Programs (QR codes are available for all volunteer opportunities):

- i. Monthly Ask A Lawyer program (Looking for volunteers, can sign up online, 2 hour commitment once per month)
 - **1.** Held second Tuesday of every monthly, from 3-5pm. One domestic relations attorney and one civil attorney.
- ii. Law Day, April 28, 2023 (Looking for volunteers, can sign up online)
- **iii.** Latin X Task Force (Assist people in other languages). The numbers for this task force have gone up very quickly.
- <u>6.</u> <u>Access to Justice/Pro Bono Program</u> Magistrate Kandace Majoros and Samantha Walsh report.
 - **a.** Access to Justice (Magistrate Majoros reports):
 - i. Thanks Ian Bonner and his team, and all other volunteers.
 - <u>ii.</u> Family Law Day and Legal Resource Day are main programs
 - **1.** Looking for volunteers
 - iii. Law Day for Older Adults (August 23, 2023 at Senior Center from 1-5pm)
 - 1. Have 3 sessions, estate planning, Medicaid, Grandparent rights, etc.
 - **2.** Colorado Bureau of Investigation will report on scams that target older adults
 - <u>3.</u> Individual attorneys will meet with folks regarding estate planning
 - <u>iv.</u> Access to Justice Committee wants to make more of an effort to honor volunteers. Justice Hart at Fall Term Day will honor volunteers that have meet the threshold of 50+ hours per year. There will also be a separate event to honor these volunteers.
 - **v.** Colorado is looking into requiring Colorado attorneys to report their pro bono work, donations, etc. This would be done confidentially.
 - **b.** Pro Bono (Samantha Walsh reports):
 - i. Samantha Walsh and Kara Clark are now co-chairs of the Pro Bono Program.
 - **<u>ii.</u>** Thank you to Cody Knebel who served for many years.
 - <u>iii.</u> Trying to find ways to increase volunteers. Because of COVID volunteers have decreased.
 - <u>iv.</u> People can volunteer weekly, through weekly pro bono intakes at the courthouse (2.5 hour commitment)
 - **1.** There is also a Loveland intake.
 - <u>v.</u> Volunteers can also be on a list for taking on pro bono cases. Can be limited representation.
 - <u>vi.</u> Providing pro bono services may be a good way to serve the community and avoid burn out.
 - <u>vii.</u> Setting up mentorship program. Attorneys would work with 3L law students on cases

7. Trusts and Estates Committee - Rikke Liska reports

- **a.** Pete Bullard is stepping down, and Rikke Liska and Kate Smith are taking over
- **b.** Next meeting is March 29, 2023 (Regarding public administrator)
- **c.** In June there will be a presentation about what to do with older documents
- **<u>d.</u>** There will also be a presentation about how to pass on credit card fees to clients, which is now allowed
- **e.** Reach out to Rikke if you would like to be added to the list.
- **f.** 1 hour CLE for each meeting.
- **g.** In-person or via zoom.

8. High School Mock Trial – David Ayraud reports

- **a.** 2023 Northern Colorado Regional High School Mock Trial Competition was held at Larimer County Justice Center on February 10-11, 2023. First time in 3 years that this was held in person.
- **b.** Mr. Ayraud reports that this competition provides an opportunity for high school students to practice trial advocacy.
- **c.** This was the first year that judges used electronic ballots, which worked great.
- **d.** 12 schools in the Northern Colorado area participated (about 150 students)
- **e.** 3 teams qualified for state:
 - i. 3rd Place Pourde
 - ii. 2nd Place Ridgeview
 - iii. 1st Place Rocky Mountain High School
- f. Next year the Regional Competition will be held in Weld County on February 9 and 10, 2024.
- g. David Ayraud, Magistrate Linda Connors, and Sunita Sharma are going to transition out, and Sara Steiben will be taking over organization of Northern Colorado High School Mock Trial for Larimer County.
- **h.** As always, volunteers will be needed.

<u>9. Professionalism Committee</u> – Honorable John Jostad reports.

- a. It's a great day to be alive.
